SECTION – I

INSTRUCTION TO TENDERER

1.1 SCOPE & TECHNICAL WORK:

The scope & technical work is as per Section IV.

1.2 CORRESPONDENCE:

All correspondences shall be made in English only to the C&P Head, UIHEP, Mukhiguda, Dist. Kalahandi, Pin: 766026.

1.3 SCHEDULE OF DATES:

The various crucial dates relating to “Painting of metallic surface of Bus duct enclosure, NGT cubicle and LAVT panel of 4 x 150 MW Generator Sets of UIHEP, Mukhiguda” are as notified in the tender notice.

1.4 COST OF TENDER PAPER:

The tender specification should be accompanied with the cost of tender paper as notified in the tender notice in shape of Bank draft / Bankers Cheque from any Nationalized Bank / Scheduled bank drawn in favour of “Odisha Hydro Power Corporation Ltd.” payable at IOB, Mukhiguda / SBI, ADB, Jaipatna along with the tender documents for the tenderers those who download the tender specification from OHPC website or original money receipt of OHPC for the tenderers those who purchase the tender specification from office of the Sr. General Manager (El.), UIHEP, Mukhiguda, failing which the tender shall be out rightly rejected.

1.5 EARNEST MONEY DEPOSIT:

The EMD amount will not carry any interest. The EMD of unsuccessful bidders shall be returned after finalization of tender. SECTION – II GENERAL TERMS AND CONDITIONS

2.1 SUBMISSION OF BID

2.1.i) **The following Documents to be submitted along with Techno-Commercial Bid in part-I in one sealed envelope super scribed as Techno Commercial Bid.**

- Tender Paper Cost
- EMD
- Self-attested copies of IT PAN and GSTIN.
- Proof of eligibility criteria as per clause No. 1.6 regarding experience.
- Download copy of the tender document / Tender paper to be signed on each page.
- Any other documents as per the check list given in Annexure – 4.
- An affidavit by the tenderer, that the firm is not black listed. (as per prescribed format in Annexure – 5)
- A declaration by the tender, that the tenderer has no relation with any employee serving under OHPC as per Annexure – 2.

2.1.ii. Price bid in the prescribed form given in Part – II in another sealed cover super scribed as “Price Bid”. Both the covers should be placed inside another sealed cover super scribed with TCN no. & marked as “**TENDER FOR PAINTING OF METALLIC SURFACE OF BUS DUCT ENCLOSURE, NGT CUBICLE AND LAVT PANEL OF 4 X 150 MW GENERATOR SETS OF UIHEP, MUKHIGUDA**” & to be sent to (or dropped in) the box kept in the office of the tender inviting authority.

2.2 CLARIFICATION & AMENDMENT

- I) At any time before submission of bid, the client may, for any reason, modify the tender documents by amendment. The amendment, if any, shall be issued through an addendum which shall be kept on the official website of OHPC for information of the firms / agencies who intend to submit quotation. Before submitting the bid the firms / agencies are advised to go through the website to find out such addendum / errata / corrigendum if any issued by the client. The addendum / errata / corrigendum will be binding on all the firms / agencies submitting the quotation. The client also reserves the right without any obligation or liability to accept or reject any or all the quotation at any stage of the process, to cancel or modify the process or any part thereof or to vary terms and conditions at any time without assigning any reason thereof.
- II) Tenderers shall carefully examine the tender documents and the technical specification. Should a tenderer find any discrepancies or omissions from the specification or other documents, he should at once intimate the authority and obtain clarification in writing. This, however, does not entitle the tenderer to ask time beyond the due date fixed for receipt of tenders.
- III) In case any bidder who has submitted the bid before issue of corrigendum / addendum etc., if desired can submit a bid super scribing as “Revised bid against TCN” on the envelope containing the tender documents.

2.3 **CORRIGENDUM:** Modification of specifications and extension of closing date or opening date of Tender, if required, will be made by corrigendum. Copies of such corrigendum will be

floated in OHPC website only. This shall be signed and shall form a part of the Tender. Tenderers are required to visit the website for such corrigendum / errata / addendum if any.

- 2.4 **SUBMISSION OF BIDS:** Bids shall be submitted as per cl. No. 2.1 of the tender specification. **Bids will be received in the office of Sr. General Manager (EI.), UIHEP, Mukhiguda, Kalahandi, Pin-766026 as per tender notice. Bids received late due to reason whatsoever will be rejected.**
- 2.5 **SITE VISIT:** The bidders are strongly advised to undertake site visit to assess the exact nature & volume of work involved and materials required before submitting their bids. The bidder may undertake site visit during any working hours before last date & time of receipt of tenders with prior intimation.
- 2.6 **OPENING OF TECHNO COMMERCIAL BID AND PRICE BID:** The Techno Commercial Bid shall be opened on the scheduled date and time as per tender notice at Office of the Sr. General Manager (EI.), Upper Indravati Hydro Electric Project, At/Po – Mukhiguda, Dist – Kalahandi, Pin-766026, Odisha in the presence of the tenderer or authorized representative of the tenderer if any who wish to be present on that spot at that time.
The price bid of only those tenderers will be opened whose techno commercial bids are found in order. The date and time of opening of the price bids of technically qualified firms will be intimated later and separately. **If the date of receipt / opening of tender happens to be or declared as a holiday, the next working day will be treated as the corresponding effective date.**
- 2.7 **EVALUATION:**
- i) Evaluation shall be based on techno-commercial and price bids submitted by the bidders.
 - ii) Bidders fulfilling the eligibility criteria as per the above evaluation shall be called for opening of the price bids.
 - iii) Bidders not meeting the eligibility criteria shall be excluded for further evaluation.
 - iv) The competent authority reserves the right to cancel any or all bids without assigning any reason thereof.
- 2.8 **OUTRIGHT REJECTION CRITERIA:**
- i) Bidders whose bid is not received in time.
 - ii) Bidders not submitting tender paper cost / EMD.
 - iii) Bidders submitting false evidences that cannot be verified during the process shall be disqualified / the contract to be terminated on detection.
 - iv) The Bidder blacklisted by any Central Government / State Government / PSU / Government Bodies.
 - v) Bidder not submitting the bid in line with the Tender requirement.
 - vi) Conditional bids shall not be considered and will be out rightly rejected in very first instance.
 - vii) Bidder not having work experience of relevant nature as per clause no. 1.6.
- 2.9 **PRICE:** The price shall be FIRM & FOR destination only at site at UIHEP, Mukhiguda inclusive of Taxes & Duties, Packing, Forwarding, Freight and Insurance. In addition, the breakup of destination price shall be given as per Price Schedule in the Price Bid.
- 2.10 **TAXES & DUTIES:**
- i) Only GST shall be paid as per rule.

- ii) Taxes deductible at source shall be deducted from the bills of the firms as per prevailing Act and Rules.
- 2.11 **BILLS:** The GST bills along with copies of PAN & GSTIN shall be submitted to the Consignee/EIC after completion of work. Part billing / payment is not allowed.
- 2.12 **VALIDITY:** The bids should have a validity period of 180 days from the date of opening of tenders, failing which the tenders will be rejected.
- 2.13 **COMPLETION PERIOD:** “Painting of metallic surface of Bus duct enclosure, NGT cubicle and LAVT panel of 4 x 150 MW Generator Sets of UIHEP, Mukhiguda” as per the specification should be completed in all respect **within 60 days from the date of handing over of site by the Engineer-in-charge (EIC).**
- 2.14 **PERFORMANCE SECURITY DEPOSIT:**
The successful tenderer has to deposit **10% of the ordered value (excluding taxes)** towards performance security deposit within 15 (fifteen) days of placement of order by OHPC in shape of Bank draft / Banker Cheque from any Nationalised Bank/ Scheduled Bank drawn in favour of “Odisha Hydro Power Corporation Ltd.” payable at IOB, Mukhiguda / SBI, ADB, Jaipatna or in shape of BG (Bank Guarantee) pledged in favour of OHPC, UIHEP, Mukhiguda as per the prescribed format at Annexure – 1. In case of non-fulfilment of the contract conditions, the security deposit will be forfeited without assigning any reason thereof. No interest shall be paid on the security deposit. The security Deposit will be released after completion of guarantee period on receipt of clearance from EIC for the work.
- 2.15 **AGREEMENT:** The contractor shall have to execute an agreement in a non-judicial stamp paper worth as applicable as per Odisha Stamp Duty Act as per prescribed format of Govt. of Odisha with Engineer-in-Charge **within 15 days of issue of order** before execution of work failing which the work order will be treated as cancelled.
- 2.16 **OHPC AUTHORITY RESERVES THE RIGHTS:**
- a) To reject any or to accept any or all tenders.
 - b) To increase or decrease the quantity of materials or to change the distribution schedule covered under the tender without assigning any reason thereof.
 - c) To split the order.
 - d) The Work order will be liable for cancellation in the event of un-satisfactory supply / delay in completion of the work and non-observance of relevant clauses of the Work order.
- 2.17 **GUARANTEE / WARRANTY:** The work / service covered by this specification should be guaranteed for a minimum period of 12 months from the date of use. A Certificate in this regard is to be furnished along with the final bill.
- 2.18 **EXTENSION OF COMPLETION PERIOD:** If the work is delayed due to reason beyond the control of the contractor, the contractor shall without delay give notice to OHPC in writing of his claim for any extension of time. OHPC on receipt of such intimation may agree to extend the delivery / completion period as may be reasonable but with prejudice to other terms & condition of the contract.
- 2.19 **JURISDICTION:** All disputes shall be under the jurisdiction of the court at the place where the authority of OHPC, who has executed the agreement.
- 2.20 **AWARD OF WORK:** The work will be awarded on the basis of L-1 rate. The order may be split and awarded on the basis of L-1 rate.
- 2.21 **SETTLEMENT OF DISPUTE:**

- i) **Amicable Settlement:** Any dispute(s) or difference(s) arising out of or in connection with the contract shall to the extent possible, be settled amicably between the parties.
- ii) **Dispute Resolution:** Decision of competent authority of OHPC shall be final and binding on both the parties in respect of all matters of dispute arising out of this tender.

2.22 **REJECTION OF MATERIALS:** If the materials/equipment supplied by the supplier are found defective in materials or workmanship or otherwise not in conformity with the requirements of the tender specification, OHPC shall either reject the materials/equipment or request the supplier in writing to rectify/replace the same. The supplier on receipt of such intimation shall either rectify or replace the defective materials/equipment free of cost to OHPC, if the supplier fails to do so, OHPC may:

- a. At his option replace or rectify such defective materials/equipment and recover the extra costs so involved from the supplier, **AND/OR**.
- b. Terminate the contract with forfeiture of Security Deposit.

2.25 **ACCEPTANCE OF ORDER:** The successful bidder shall confirm by returning a duplicate copy of the work order to this office duly signed on each page within 15 days from the date of issue of work order as a token of acceptance.

SECTION – III
SPECIAL TERMS AND CONDITIONS

3.1 TERMS OF PAYMENT:

100% Payment along with Taxes and Duties as applicable for the work shall be paid within 45 days of successful completion of work and verification thereof by the EIC subject to submission of security deposit, GST bill in triplicate, warranty certificate and copy of GSTIN & PAN through cheque (subject to deduction of TDS if any).

3.2 ENGINEER-IN-CHARGE:

The Divisional Head, Maintenance Division, UIHEP, Mukhiguda.

3.3 PAYING OFFICER:

The Finance Wing Head, UIHEP, Mukhiguda.

3.4 LIQUIDATED DAMAGE FOR DELAY IN COMPLETION OF CONTRACT:

If the supplier / contractor fails to complete the work within the scheduled completion period specified in the contract or any extension granted there to, the purchaser shall recover from the supplier / contractor, liquidated damage @ 0.5% of the ex-work contract price for each calendar week of delay or part thereof of delay. For this purpose, the date of receipted challan by the EIC shall be reckoned as date of delivery. The total amount of liquidated damage shall not exceed 5% (five percent) of the total contract value (ex-work price).

3.5 FORCE MAJEURE: The supplier shall not be liable for any liquidated damage for delay or for failure to perform the contract for reasons of force majeure such as act of God, act of public enemy, acts of Government, fires, flood, epidemics, quarantine restriction, strikes, freight embargoes provided that the supplier has brought to the notice to the customer in writing of the cause of delay in advance. The customer shall verify the facts and grant such extensions as the facts justify.

SECTION – IV **SCOPE & TECHNICAL SPECIFICATION**

4.1 **SCOPE OF WORK:** The work has provision for scraping of old paints, applying one coat of approved primer & final two coats of approved enamel paint as per IS standard on all metallic surfaces of Bus duct enclosure, NGT cubicle and LAVT panel of 4 x 150 MW Generator Sets of UIHEP, Mukhiguda as per specification which shall be compatible to the existing system. Colour of paint is to be chosen taking into colour code guidelines & as per the direction of EIC. Intensity or shade of colour should be so chosen to be easily distinguished from a considerable distance.

Any portion of the work and supply of materials related to the works, which may not have been specifically mentioned in the specification but which are required and necessary for the completeness of the works shall be deemed to have been included in the contract and shall be completed by the supplier / contractor at no extra cost to OHPC.

4.2 **STANDARDS:** The materials shall confirm to the specification/description as mentioned in the price schedule and clause No 4.5.

4.3 **CLIMATIC AND SERVICE CONDITIONS:** The Climatic conditions at site under which the Equipment shall operate satisfactorily are as follows:

- a) Maximum ambient Temperature – 50°C
- b) Maximum daily average ambient Temperature - 45°C
- c) Maximum yearly weighted ambient Air Temperature -32°C
- d) Maximum relative humidity – 100 %
- e) Maximum Annual Rain fall – 2860 mm
- f) Minimum Annual Rain Fall – 1527 mm
- g) No. of months during which Tropical Monsoon conditions prevails – 5and ½ Months.

4.4 **FITTINGS AND ACCESSORIES:** All fittings and accessories which may not be specifically mentioned in the specifications but are usual and necessary for equipment shall be deemed to be included in the contract and shall be supplied by the supplier / contractor without any extra cost to the customer.

4.5 **TECHNICAL SPECIFICATION –** Painting of outer metallic surface of Bus duct enclosure, NGT cubicle and LAVT panel of 4 x 150 MW Generator Sets of UIHEP, Mukhiguda shall be done as per details given below –

We, the Bank Limited further agree with OHPC that OHPC shall have the fullest liberty, without our consent and without affecting in any manner our obligations hereunder, to vary any of the terms and conditions of the said agreement to extend time of performance by the said Contractor(s) and to forbear or enforce any of the terms and conditions relating to the said agreement and we shall not be relieved from our liability by reason of any such variation, postponement, or extension being granted to the said Contractor(s) or by any such matter of thing whatsoever which under the law relating to sureties would but for this provision have effect of so relieving us.
5. This guarantee shall not be discharged due to the change in the name, style and constitution of the Bank or the Contractors(s) / supplier(s).
6. We, the Bank Limited lastly undertake not to revoke this guarantee during its currency except with the previous consent of OHPC in writing.
